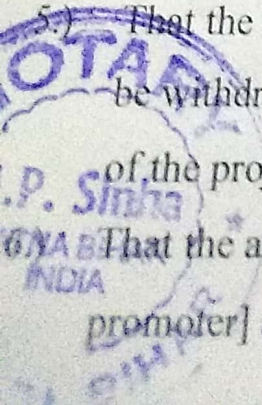
2.) That the said land is free from all encumbrances. or That details of encumbrances including the details of any rights, title, interest, dues, litigation and the name of any party in or over such land.
