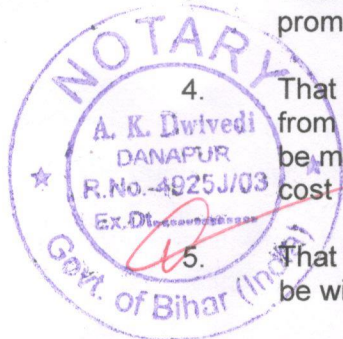
I, Rajesh Kumar Sharma [promoter of the Project/duly authorized by the promoter of the project] do hereby solemnly declare, undertake and state as under:

2. That the said land is free from all encumbrances, or
That details of encumbrances Rajesh Kumar Sharma including details of any rights, title, interest does, Litigation and name of any party in or over such land.
3. That the time period within which the project shall be completed by [me/the promoter] is 3 years (Three Years)
4. That seventy percent of the amount realized by me for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
5. That the amount from the separate account, to cover the cost of the project, shall be withdrawn by me in proportion to the percentage of completion of the project.
6. That the amount from the separate account shall be withdrawn by me after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.

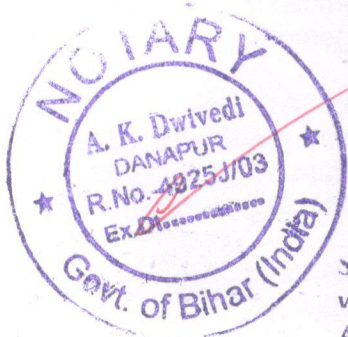
