
3. That the time period within which the project shall be completed by (me/the promoter) is 25.08.2026
4. That seventy percent of the amounts realized by (me/the promoter) for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for the purpose be withdraw by (me/the promoter) in proportion to the percentage of completion of the project.

6. That the amounts from the separate account shall be withdrawn by me/the promoter) after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
7. That (I/the promoter) shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the percentage of completion of the project.
8. That (I / the promoter) shall take all the pending approvals on time, form the competent authorities.
9. That (I/the promoter) have/has) furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
10. That (I /the promoter) shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.



