Affidavit cum Declaration of Mrs. Sweta Verma promoter of the proposed project / duly Authorized by the promoter of the proposed project, vide its/his/their authorization dated 26.03.2018.

I, Sweta Verma, W/o Subodh Verma, as Director of the Promoter Company M/s Satvika Bindhyawasinis Const. Pvt. Ltd., having its Registered Office at 601, Gopi Tower, Saguna More, Danapur, Patna -801503 (promoter of the proposed project) do hereby solemnly declare, undertake and state as under:

1. That I, Sweta Verma, W/o Subodh Verma on behalf of M/s Satvika Bindhyawasinis Const. Pvt. Ltd. declares that Sh. Anil Kumar Gupta, S/o Late Sh. Shiv Lal Gupta, Resident of Bhadra Ghat Idgah Road, PS- Alamganj, PO- Gulzarbagh, Distt. Patna in the state of Bihar have a legal title to the land on which the Development of the project named "TRINETRI DHAM" is proposed and the Promoter has acquired the right of Construction on the land vide Agreement dated 10.12.2016 between Land Owner and the Promoter for the Development of the Proposed Real Estate Project which is enclosed herewith.
2. That the said land is free from all encumbrances.
3. That the time period within which the project shall be completed by me/promoter is 750 working days approx.
4. That seventy per cent of the amounts realised by promoter M/s Satvika Bindhyawasinis Const. Pvt. Ltd. for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project.

6. That the amounts from the separate account shall be withdrawn after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
7. The Promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
8. The Promoter shall take all the pending approvals on time, from the competent authorities.
9. The Promoter have / has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
10. The Promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
