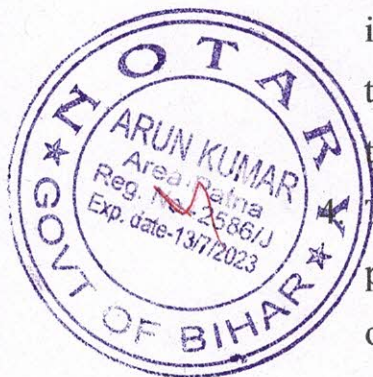
Affidavit -cum-Declaration

Affidavit cum Declaration of Mr ABINASH KUMAR, as Director of M/S MAHADEV DEVELOPERS having registered office at Shop no-5, Manna surti complex, Lohia nagar, Kankarbagh, PS-Kankarbagh, PO-Lohia nagar, Patna, 800020 promoter of the project do hereby solemnly declare,

ABINASH KUMAR, (DIRECTOR OF M/S MAHADEV DEVELOPERS [Promoter of the proposed project SHANTI COMPLEX]) have legal title to the land on which the development of the proposed project is to be carried out and a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.

That we shall get the accounts audited within six months after end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
7. That we shall take all the pending approvals on time, from the competent authorities.
8. That we have furnished such other documents as have been prescribed by the Act and the rules and regulations made hereunder.
9. That we shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.

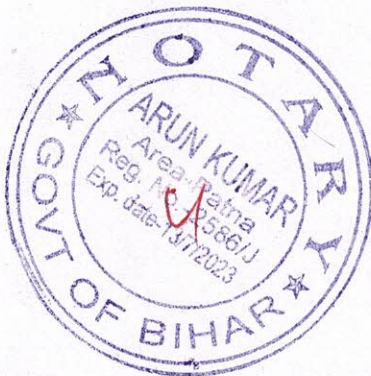
