I Dinesh Kumar Tiwari being Director of Technoculture Building Centre Pvt. Ltd. do hereby solemnly declare, undertake and state as under:

1. That Technoculture Building Centre Pvt. Ltd. [have / has] legal title to land on which the development of project Vihar ARA Ph-03 is proposed.
2. That the said land is free from all encumbrances.
3. That the project is situated at Mauja Kulharia and comes under Nagar Panchyat Koilwar.
4. That the time period within which the project shall be completed by (me / the promoter) is 36 months. Date of completion is 30-04-2025.
5. That seventy percent of the amounts realized by [me / the promoter] for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
6. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn by [me / the promoter] in proportion to the percentage of completion of the project.
7. That the amounts from the separate account shall be withdrawn by [me / the promoter] when it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
8. That [I / the promoter] shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.

That [I / the promoter] shall take all the pending approvals on time, from the competent authorities.

10. That [the promoter] [have / has] furnished such other documents as have been prescribed by the Act and the rules and regulations made under the Act.
11. That [the promoter] shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.

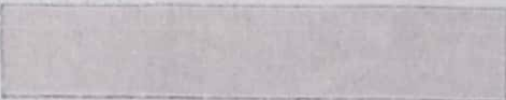
