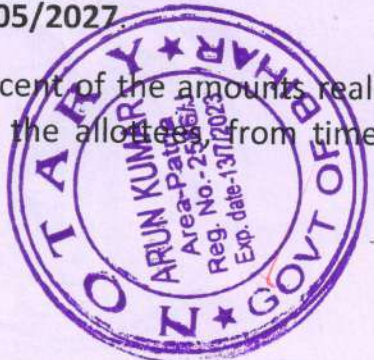
2. That, the said land is free from all encumbrances.
