## Affidavit-cum-Declaration

Affidavit cum Declaration of [Mr. PARAS KUMAR] [promoter of the project/ duly authorised by the promoter of the project, vide its/ his/ their authorisation dates];

That seventy per cent. of the amounts realised by [me /the promoter] for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- 5. That the amounts from the separate account to cover the cost of the project shall be withdrawn by [me /the promoter] in proportion to the percentage of completion of the project.
- 6. That the amounts form the separate account shall be withdrawn by [me / the promoter] after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in portion to the percentage of completion of the project.
- the promoter] shall get the accounts audited within six months after the end of every financial ear by a chartered accountant in practice, and shall produce a statement of accounts duly certified and

singed by such chartered accountant and it shall by verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.

- 8. That [I / the promoter] shall take all the pending approvals on time, from the competent authorities.
- 9. That [I/ the promoter] [have /has] furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
- 10. That [I /the promoter] shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.
