

5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn by (me the promoter) in proportion to the percentage of completion of the project.

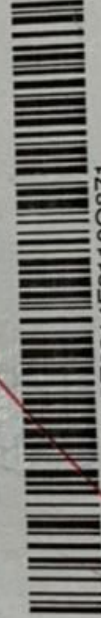
