


Affidavit cum Declaration of Mr. Sanjay Kumar, (promoter of the project, vide its/his/their authorization dated)

1. That I/ promoter have legal title to the land on which the development of the project is proposed or Mr Sanjay Kumar has a legal title to the land on which the development of the proposed project is to be carried out and A legally valid authentication of the title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.
2. That the said land is free from all encumbrances or That details of encumbrances ..... including details of any rights, title, interest, dues, litigation and name of any party in or over such land.
3. That the time period within which the project shall be completed by me/promoter is 31.12.2021
4. That seventy percent of the amounts realized by me/the promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

6. That the amounts from the separate account shall be withdrawn by me/ the promoter after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in promotion to the percentage of completion of the project.

8. That I/the promoter shall take all the pending approvals on time, from the competent authorities.
9. That I/ the promoter have/ has furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
10. That I/ the promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.
