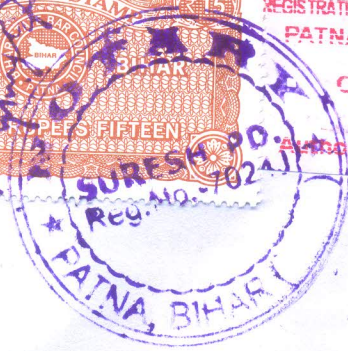

AFFIDAVIT CUM DECLARATION

I, JITENDRA KUMAR SINGH, son of Sri Rup Narayan Singh as Managing Director of the promoter company M/s APNA AWAS CONSTRUCTION PVT. LTD., having its registered office at 001, Sundram Enclave, Kitab Bhawan Lane, North S.K. Puri, P.S – Shrikishnapuri, Town & District – Patna in the state of Bihar, PIN-800013 (promoter of the proposed project) do hereby solemnly declare, undertake and state as under.

1. 

6. That the amount from the separate account shall be withdrawn after it is certified by an engineer, an architect and a chartered accountant in practice that withdrawal is in proportion to the project.
7. That the promoter shall get the account audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of account duly certified and sign by such chartered accountant and it shall be verified during the audit that the amount collected for a particular project have been utilized for percentage of completion of the project.
8. That the promoter shall take all the pending approvals on time, from the competent authorities.
9. That the promoter has furnished such other documents as have been prescribed by the rules and regulations made under act.
10. That the promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be on any ground.

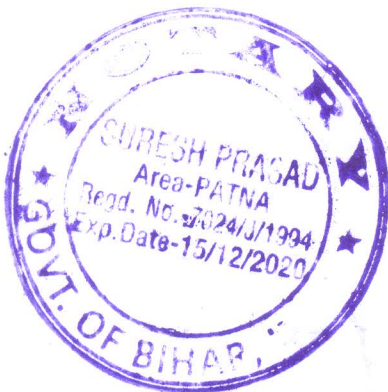
