- (iv) The real estate agent shall facilitate the possession of all information and documents, as the allottees is entitled to, at the time of booking of any plot, apartment or building, as the case may be;
- (v) The real estate agent shall provide assistance to enable the allottees and promoter to exercise their respective rights and fulfil their respective obligations at the time of booking and sale of any plot, apartment or building, as the case may be;
- (vi) The real estate agent shall comply with the provisions of the Act and the rules and regulations made there under;
- (vii) The real estate agent shall not contravene the provisions of any other law for the time being in force as applicable to him;

- The real estate agent shall discharge such other functions as may be specified by the (viii) Authority by regulations. commencing from
- The registration is valid for a period of five years 17.02.2025 and ending with 16.02.2030 unless renewed by the Authority in accordance 3. with the provisions of the Act or the rules and regulations made there under.
