

 - d. The registration shall be valid for a period of 04 Years 10 Months commencing from 17/5/2022 And ending with 15/03/2027 (Subject to extension of validity of map from Competent Authority) unless extended by the Authority in accordance with the Act and the rules made there under;
 - e. The promoter shall comply with the provisions of the Act and the rules and regulations made there under; along with details as prescribed under Rule 16(1) (a)(b)(c)(e) of Bihar Real Estate (Regulation and development) Rule, 2017.
 - f. The promoter shall not contravene the provisions of any other law for the time being in force as applicable to the project.

- 8) Registration is granted with the condition that the promoter should submit LPC/Mutation mentioning the area corresponding to individual plot within one month failing, which the registration will be revoked under section 7(1)(b) of the Act.
