

Also provide details of cases, if any, filed against these projects along with copy of the order passed in these cases and proof of compliance done by you.

- 8. Notice of Commencement in Form-X, which have duly stamped by the competent Authority (As the submitted one is not duly stamped by the competent Authority).
- 9. A copy of the land deed for whole parcels of land, as you have submitted sale deed in the name of Jayant Vishnu only and that too for 6.1 Decimal of land whereas the land required for the project is 18.22 Decimal.
- 10. NOC issued by registrar of cooperatives mentioning that the society has no problem if a multistoried apartment is constructed on the cooperative land which would be sold to different allottees who would be entitled to the same facilities otherwise other cooperative members are entitled to. As from the sale deed it is clear that the land belongs to a cooperative society.

Revised copy of affidavit of Memorandum of a division of share between Promoter and landowner available for marketing and selling on Affidavit cum declaration in prescribed format duly signed by Promoter and Land Owner in the light of O.O No.-115 date: 01/08/2023 available on RERA portal. Each flat no. and parking space should carry a unique no. and as there are three landowners in this case, no. of flat and parking space (with unique no.) allotted to the landowners. The document should have signature of landowners and promoters.
- 17. Revised copy of Form B (Form B is not as per the template given the Bihar Real Estate 9 Regulation and Development, Rules 2017). The document must have name of landowners and also end date of project in dd/mm/yyyy format.
