

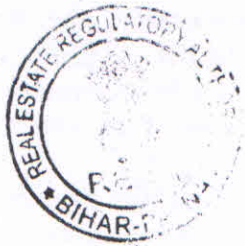




- 1) The promoter-Pinnacle Engicon Private Limited share is 65% in the proposed project-P.S. Complex.
