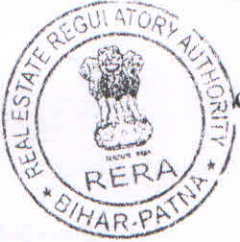



 - The promoter shall comply with the provisions of the Act and the rules and regulations made there under; along with details as prescribed under Rule 16(1) (a)(b)(c)(e) of Bihar Real Estate (Regulation and development) Rule, 2017.

- 9) The certificate is being issued on the declaration of Promoter that he could not get the copy of the NAKAI at the time of Mutation, though he has submitted LPC issued from the office of CO and Revenue receipt with updated payment.
