As per Regulation 10 of Bihar RERA/Gen.Regulations/2024; dated: 01/08/2024, the promoter is directed to pay an additional charge of Rs. 10,00,000/- (Rupees ten lakh) along with an extension fee of Rs one lakh for making an application for the extension of the registration of a real estate project.
3. The compelling circumstances and reasons for failing to complete the project during the stipulated time period as well as promoter need to satisfy that the progress of the project has reached to a level where completion is possible in the given time frame.
4. Late charge of Rs. 2,00,000/- (Rupees two lakh), as per Regulation 11 of Bihar RERA/Gen.Regulations/2024, for a delay of more than one year from the date of application for extension of registration of the project.

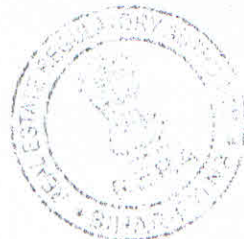
