
2. This registration is granted subject to the following conditions, namely :-

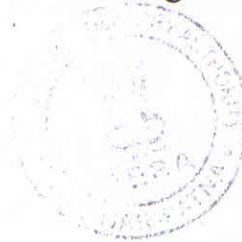

- The promoter shall deposit seventy per cent. of the amounts realized by the promoter in a separate account to be maintained in a schedule bank (Bank of Baroda, Branch Name- Raja Bazar Branch, Patna, Account No. 83970200001219, IFSC Code : BARB0VJRABZ) to cover the cost of construction and the land cost to be used only for that purpose as per sub-clause(D) of clause (1) of sub-section (2) of Section 4;
- The registration shall be valid for a period of 02 years 04 Months commencing from 22-09-2021 And ending with 2024/01/20 (Subject to extension of validity of map from Competent Authority) unless extended by the Authority in accordance with the Act and the rules made there under;

- 8) Onus of getting the development agreement extended up to completion date would be on the promoter failing which registration would be revoked.


