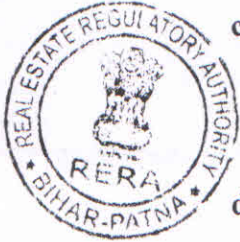





- 8) **In case of any papers not found in order, the same should be made available within one month.**






