- 2. A revised map is needed with corrections. As the map shows the building as a residential building, while in the development agreement, it has been mentioned as Residential-cum-Commercial Building. Also, the share division affidavit, which is incomplete, shows distribution of commercial space (Shops), indicating it to be a residential-cum-commercial building.
- 3. LPC, CRR and jamabandi for 17.40 Decimal of land in the name of Sri Pandey Alok Kumar, Sri Pandey Arun Kumar. Sri Sarang Pandey, Smt. Usha Pandey and Smt. Jyoti Sinha landowners only. As per the development agreement, the landowners are Sri Pandey Alok Kumar, Sri Pandey Arun Kumar. Sri Sarang Pandey, Smt. Usha Pandey and Smt. Jyoti Sinha, whereas land documents like CRR, LPC, and Jamabandi are not submitted in the name of the above-mentioned landowner.
