- Current Non encumbrance certificate [NEC] for the whole parcel of land with correct land details mentioned in it.
- 2. A statement of assets and liabilities of the Directors of the Promoter's entity as of the date of submitting the application, duly certified by the Chartered Accountant CA, to show the financial worth of the promoter to meet at least ten percent of the estimated development cost of the project to take up the initial cost of the project.
- 3. A certificate from a Chartered accountant is required, declaring that no advance/booking amount has been taken from the customers against the current project.

As per the Bihar RERA/Gen.Regulations/2024; dated: 01/08/2024, the promoter needs to provide an affidavit, with the full details of movable and immovable properties of this concern along with details of such properties of its directors/ partners/ proprietor/ other entity (Directors and firm both).   - 8. Consent on the affidavit of the two-thirds of allottees with Email ID/ Address, and Contact no. who have booked flats in the block A and B.
  - 9. An affidavit of the promoter mentioning that the names and no. of allottees are true and any discrepancy would lead to penal action and the same affidavit should also mention that of delay in completion of the project due to alteration in map would not deny the right of seeking compensation to allottees who had made bookings prior to alteration that every allottee would get separate parking spaces.
  - 10. The consent of two-thirds of the allottees of existing block A and B individually in the affidavit, stating that they have no objection if the construction of a new block C and D, Additionally, the affidavit must include their consent stating that they have no objection in the construction "If any" change in their proportionate share in the project land takes place.
