<u>O R D E R</u>

Learned counsel Mr. Kishore Kunal on behalf of the complainant is present but the respondent - promoter neither appeared before the Conciliation Forum nor has appeared before this Bench in spite of notice sent to him by the office on 28.04.2025.

2. Learned counsel for the complainant submits that Agreement dated 21.02.2019 was executed between the an complainant and the respondent to purchase Plot no.741 having area of 2700 sq. ft. in the project "Kabir Nagar" situated at Chirouri Naubatpur, Patna, on consideration amount of Rs.17,01,000/-, which was paid by the complainant in ten installments between 20.02.2019 to 12.12.2019, against which the respondent issued payment receipts which are kept on record. He also submits that the respondent promoter had assured the complainant that delivery of possession of the plot would be made within the specified period of time, but till date the respondent neither delivered possession of the plot nor developed the project nor refunded the principal amount. Hence, this complaint has been filed by the complainant for refund of principal amount along with interest and compensation.

3. It is evident from the record that the respondent neither appeared before the Conciliation Forum nor has appeared before this Bench in spite of notice sent on 25.04.2025.

4. Perused the record. The Bench observes that the respondent - promoter neither honoured the commitment made to the complainant of completing the project and handing over possession of plot to the complainant within the time granted nor refunded the

principal amount of the complainant when he failed in delivering possession of plot to the complainant. The respondent is also not showing interest in getting this case disposed of by appearing in this case in spite of service of notice upon him. The Bench presumes that the respondent – promoter has nothing to say in this matter as on every date either before the Conciliation Forum or this Bench he chose not to appear in the case so as to linger the matter for indefinite period. In such a situation, the Bench is left with no option but to pass the order exparte on merit on the basis of material available on the record as the case cannot be allowed to remain pending for an indefinite period.

5. In the backdrop of the submissions made by learned counsel for the complainant and on going through the material available on record, the Bench directs the respondent company and its Director Mr. Musheer Ahmad and other Directors to refund the principal amount of Rs.17,01,000/- to the complainant along with interest at 2% above marginal cost of the lending rate (MCLR) of the State Bank of India on the total principal amount which becomes due till the date of payment within sixty days of this order.

6. The complainant is at liberty to press other claims, if any, which are in the nature of compensation, before the Adjudicating Officer, RERA.

With the aforesaid observations and directions, this case is disposed of.
