**O R D E R**

On order of the Authority, notices were issued to both the parties for appearance in the present execution case and with direction to the respondent to comply with the order dated **07/08.08.2023**, which later on stood rectified vide order dated **11.09.2024**, passed by Shri Naveen Verma, Hon'ble Chairman of the Authority in **RERA/CC/1014/2020 / RERA/AO/284/2020** and to refund the principal amount of **Rs. 5,51,000/-** along with interest to the executant / complainant, whereon Shri Kishore Kunal, learned counsel on behalf of executant is physically present, but Shri Satwik Singh, the representative of respondent company appears through virtual mode. On query, the representative of respondent company expressed his inability to comply the above order of the Hon'ble Chairman of the Authority.

2. It is observed that neither the respondents have complied with the order dated **11.09.2024** passed in the above case by Hon'ble Chairman of the Authority nor are they ready to comply. In such view of the matter, the executant cannot be left to suffer for indefinite period as the court has to do justice equally to both the parties.

3. Since the executant has requested for refund with interest, the Bench notes that it is the responsibility of the Directors of the respondent company to arrange the necessary resources to process the refund to the executant.

4. Therefore, in the light of section 40 (1) of RERA Act, read with Rule 25 of Bihar RERA Rules, 2017, the above amount along with the accrued

interest has to be recovered from the respondent and the same has to be paid to the executant. Accordingly, the recovery certificate with a copy to the executant under section 4/5 of Bihar and Orissa Public Demands Recovery Act, 1914 be issued and sent to the Collector, Patna for recovery of the above amount of **Rs. 5,51,000/-** along with interest as per the order dated **11.09.2024** passed by Hon'ble Chairman of the Authority in the above case. The Collector, Patna is requested to inform the Authority about the continuous process of action taken from time to time and finally after the refund is made to the Executant.
