## **PROCEEDING**

- 1. Hearing taken up.Learned counsel Mr. Shyam Nandan Thakur appears on behalf of the complainants. Learned counsel Mr. Bijay Bhushan Prasad appears on behalf of the respondents.
- 2. On the previous date of hearing, the learned counsel for the respondent had promised to pay 25% of the principal amount to the complainants. He had also committed to submit a payment schedule for the rest of the amount to be refunded.
- 3. The said request of the learned counsel for the respondents was accepted by this Court and the warrant was put on hold subject to compliance of the order today. The instant case is analogous to 18 other cases, where the learned counsels for both the complainants and the respondent are also the same. As it would be an unnecessary waste of time to deal with all the analogous cases separately, the 19 cases appertaining to the respondent, where the learned counsel for all the complainantsare the same, are therefore, being clubbed for the purpose of convenience and expeditious disposal.
- 4. A chart mentioning the payment details has been submitted by the learned counsel for the respondentwhich is part of record.

5. Learned counsel for the complainants files the details of the amount of payments made by the respondent with respect to the previous order, wherein 25% of the principal amount was committed to be refunded. The details of the same are given as under:-
