PROCEEDING

- 1. Hearing taken up. The complainant is present. Nobody appears on behalf of the respondent.

- 6. As the complainant has to face the respondent which have been absconding for quite some time, it seems appropriate that the provisions beyond the RERA Act may also be invoked for justice to the complainant.
- 7. In view of the situation mentioned above, the complainant is at liberty to file a criminal case against the respondent for absconding under Section 206, 316, 318 and 319 and other relevant provisions of Bhartiya Nyay Sanhita, 2023. In case he files criminal case against the respondent he may provide the same to the Authority for the purpose of necessary action.
