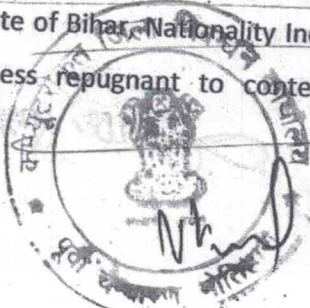

Further Branch or Branches may also be opened at any place either under aforesaid name or style or in any other names as mutually may be settled among the partners. That the Nature of Business and any other related work may be settled or agreed amongst the partners.
3. The Capital invested and/or loan advance by the partners hereto or any of them stands on the books of accounts of partnership in his/her name and will not carry any interest or may carry interest as such rate as may mutually settled or agreed upon and such interest will considered as a business expenses.

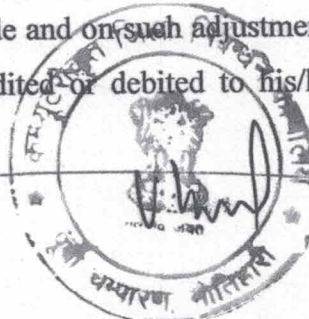
4. That the partners hereto will share the net profit or loss in the business in the following proportion:-

5. That the books of account or Accounts may be opened in the name of the partnership firm or in any other name as may be mutually agreed upon among the partners in one or more bank or banks and such accounts will be operated by the First Partner and Second Partner either and survivor only.

9. Such Notice, however, will not be necessary, if he/she retires with the consent of other remaining partners unless or otherwise mutually settled and agreed in sitting accounts among the partners no value will be put on the goodwill of firm.

10. That each of partners may give two months' notice in writing to other partners for retirement from the partnership firm and in such event if the other partners desire to continue the business, he/she /they will be entitled to do so and the notice of retirement so given by partner will be considered as a notice of his/her retirement.

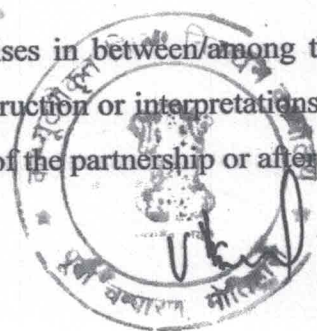
11. That the firm will not be dissolving on the death of any partner. 13. That it is agreed upon by the partners that the all partners entitled (individually) to above full control of management of the firm. And will be entitle to sign agreement, papers, bills deeds, documents, and receive payment and effectual receipts in this discharge thereof and do other deed and acts as may be necessary in the name of and on behalf of firm.

15. That no partners will be entitled to obstruct in normal carrying on of the business of the partnership or in any way to do anything against the interest of firm.
16. That for matters not provided herein, the provision of Indian Partnership Act, 1932 will apply.
17. That the capital requirement of the firm for the purpose of this business shall be met with as per mutual; convenience of partners.


