To carry on business of construction work in the field of commercial, residential, highway infrastructure development, bridge construction, environment engineering, traffic transport management, to prepare lay out, design, develop, construct, build, erect, demolish, re-erect, alter, repair, re-model, rehabilitation or do any other work in connection with any building or house scheme, roads & bridges, reclamations, improvements, contract of builders for civil/electric/mechanical/environmental and Supply of all kinds related to construction like white & red sand, cement etc and do all kinds of construction and agency business as related to the construction & manufacturing industry and also to advice for and / or to purchase acquire, take on lease, or in exchange of in any other lawful manner any area, land, buildings, structures and to develop the same to dispose them of or to maintain the same and to build township, markets or other buildings or conveniences like drainage facility, electric, telegraphic, telephonic, television, internet installations and to deal with the same in the manner whatsoever may be act as colonizers.
