

- 4. **Salary**: Pay will be as per the general principle of 'pay minus pension', i.e., while the last pay drawn shall be reckoned for pay fixation, the entire pension shall be deducted from the pay so fixed.
- 5. Eligibility: Incumbent must be a Retired Officer of Bihar Administrative Service Cadre having served in the Government of Bihar not below the rank of Special Secretary, under 62 years of age as on 01.06.2025, having no adverse reporting during service tenure and having no proceedings, either disciplinary or criminal, pending. The candidate should be proficient in working on computers and the ability to work online/e-Office. Preference would be given to persons who have served in the Department of Revenue and Land Reforms or Urban & Housing Development Department of the Government of Bihar and having experience of Revenue Courts, Certificate Officer (Public Demand Recovery) and Public Greivance Redressal.
- 6. **Job Profile**: Senior Land Revenue Officer shall exercise his powers and perform his duties under the control of the Authority. He will be in charge of all matters relating to management of grievances redressal and Public Demand Recovery. He may be delegated with other duties as considered necessary by the Competent Authority.


