1. SCOPE OF SUPPLY

II. AV Receiver

- Channels: 7.2 (Suitable for future expansion)
- Power Output: e.g., 100 Watts per channel
- Video Support: 4K Ultra HD, HDR and Dolby Vision

2. ELIGIBILITY CRITERIA

- 3.3. Sound System will have to be installed at the office of RERA Bihar

4. BASIS OF OFFER / SELECTION PROCEDURE

- 4.1. Quoted price should be Inclusive of all.
- 4.2. Lowest responsive evaluated Supplier will be awarded the Supply order.
- 4.3. Committee of RERA Bihar will scrutinize all submitted applications and select the lowest evaluated responsive Supplier to award supply order. In case of more than one lowest applicant, decision of the committee will be final.



4.4. Committee in order to arrive at lowest evaluated responsive supplier may consider the quality and specification of various makes of suitable sound system.


5. OTHER TERMS AND CONDITIONS
