## Screening of shortlisted candidates applied for the Internship for Law Graduates

The written test for the screening of Law Graduates for Internship will be held from 11.AM to 01.00 PM on 17<sup>th</sup> August, 2021 in the campus of Chanakya National Law University, near Jakkanpur Police Station, Nyaya Nagar, Mithapur, Patna- 80001. The location map may be seen on the website of CNLU at 'cnlu.ac.in'.

Candidates are expected to reach the Examination Centre, Chanakya National Law University, Patna between 09:30AM to 10:00 AM, so that adequate time is available for verification of Admit Card, thermal screening and sanitization. Candidates are required to occupy the allotted seat by 10.30 AM in the Examination Hall.

Candidates are required to report for the interview 30 minutes before the scheduled time.

The list of candidates and allotted session for interview will also be available at the notice board of the examination centre.

During entrance candidates need to keep their Admit Card with them along with a valid Identity Proof in Original viz. ADHAR/ PAN/ Passport/Driving Licence/ID issued by Bar Council of India. Admit Card can be downloaded from the website of RERA, Bihar "rera.bihar.gov.in" using User Id and password created by you during submission of application.

Candidates need to bring with them the original certificates of qualification and date of birth for verification and their photocopies. A set of photocopies thereof would be submitted by them before the interview Board.

Candidates would be tested on their knowledge and application of the Real Estate (Regulation and Development) Act, 2016, Bihar Real Estate (Regulation & Development) Rules, 2017 and relevant Case Judgements.

During test, mobile or any electronic gadget is not allowed. Candidates need to carry ball point pen of blue or black colour only.

For test no travelling or other allowance in admissible, candidates need to make stay arrangement of their own.

Candidates need to strictly follow the COVID appropriate behaviour including wearing mask and observing social distancing. On entry they will be subjected to thermal Screening and sanitization.
