- 2.1. Film makers should be empanelled with Information and public relation department Government of Bihar.
2.2. Film makers should have at least 3 years of experience of doing similar work.
2.3. Film makers must be registered with GST.
2.4. The concept paper on the topic on which the film maker proposes to make the film.

3. DELIVERABLES

- 3.1. Awarded work to be completed in 15 days from the date of handing over the work order.

4. BASIS OF OFFER / SELECTION PROCEDURE

- 4.1. Quoted price should not be more than Government approved rate.
4.2. Quoted price should be inclusive of all.
4.3. Lowest responsive evaluated film maker will be awarded the work order.
4.4. Purchase committee will scrutinize all submitted applications and select the lowest evaluated responsive film maker to award work order. In case of more than one lowest applicant, decision of selection committee shall be final.

5. OTHER TERMS AND CONDITIONS

- 5.1. Selected film maker would be made payment after satisfactory completion of work.
5.2. Except the quoted price film maker will not be entitled to claim any additional money.
5.3. Statutory deduction if any, will be made as per prevailing rules at the time of making payment.
