Subject:- Incorporation of I.S. 456:2000 and I.S.:4326:1993, Edition 3.2 (2002-04) guidelines in the drawings by map passing authorities-regarding.

Sir.

I am directed to say that Authority in its meeting on 22.02.2021 has discussed on the issue of incorporating the provision of I.S.456:2000 and provisions of Earthquake Resistant Design and construction of Buildings (I.S:4326:1993) Edition 3.2 (2002-04) in true spirit in the drawings, approved by different passing authorities of Bihar and which are finally submitted in RERA, Bihar by the promoter for registration of the project.

During the scrutiny of drawings it was found that in some of the drawings which are approved by different passing authorities of Bihar, M15 grade of concrete. i.e. of (1:2:4) nominal mix in reinforced cement concrete in beams and columns of the buildings in place of M20 grade of concrete i.e $(1:1\frac{1}{2}:3)$ nominal mix is being used even now, while in I.S. 456:2000, it has been clearly mentioned that in R.C.C. work, minimum grade of concrete should be M20. Moreover guidelines as mentioned in I.S.:4326:1993 Edition 3.2 (2002-2004) with regards to Earthquake resistant design are not specifically mentioned in the drawings.

Hence I am directed to request you to kindly instruct all the drawing/map approving authorities under your jurisdiction to incorporate the guidelines mentioned in I.S.456:2000 in drawings in true spirit. Accordingly, no concrete mix leaner than M20 grade of concrete should be used in structural part of the building. In addition to that the provisions of Earthquake resistant design and construction of Buildings (I.S.:4326:1993) Edition 3.2 (2002-04) should be incorporated in the drawings approved by different passing authorities of Bihar

This issues with the approval of Competent Authority.
